# Why this Conference

The regulatory environment for listed companies has been undergoing an evolution over the last few years with Securities and Exchange Board of India (SEBI) taking the lead in this area.

One of the important reforms in the listing space is the amendments to SEBI (Listing Obligations and Disclosure Requirements) Regulations, 2015, which were notified in May 2018, based on the recommendations of Uday Kotak Committee Report on Corporate Governance. Some of the important provisions such as appointment of woman independent director, etc., have already come into effect from April 1, 2019.

SEBI has also made wide-ranging amendments to SEBI (Prohibition of Insider Trading) Regulations, 2015 and these amendments are effective from April 1, 2019. The major reforms include maintenance of a structured database of insiders, separate code of conduct for fiduciaries, etc.

Against this backdrop, National Institute of Securities Markets (NISM) and National Stock Exchange of India Ltd in collaboration with KKR India Advisors Pvt Ltd and Aditya Birla Sunlife AMC Ltd, have organised this Conference.


