Applications are invited from eligible contractors for the captioned work in NISM campus situated at Plot Nos. IS-1 & IS-2 Patalganga Industrial Area, Mohopada, Rasayani, Dist. Raigad, Near Navi Mumbai, Maharashtra 410 222.

The estimated cost of work is Rs. 4.13 Crores.

NISM is a public trust, established by the Securities and Exchange Board of India (SEBI), the regulator for securities markets in India. NISM seeks to add to market quality through educational initiatives. It is an autonomous body governed by its Board of Governors.

Currently, NISM has been operating from its campus situated at Plot Nos. IS-1 & IS-2 Patalganga Industrial Area, Mohopada, Rasayani, Dist. Raigad, Near Navi Mumbai, Maharashtra 410 222. The premises are having a built-up area of 7.00 lakh sq. ft. on plot of lands admeasuring about 70 acres.

Eligibility Criteria

The contractor fulfilling following criteria may apply:

1. The contractor should have its office / establishment in Mumbai / Navi Mumbai/ Thane/ Raigad/ Pune.
2. The contractor should have satisfactorily completed at least any of the following work (s) during the last 7 years as on August 31, 2024:

One similar work* costing not less than Rs. 3,30,40,000/-

OR

Two similar works* each costing not less than Rs. 2,06,50,000/-

OR

Three similar works* each costing not less than Rs. 1,65,20,000/-

The period of 7 years for the purpose of having completed similar work(s) shall be from 01.09.2017 to 31.08.2024.

3. The annual average turnover of the contractor should not be less than Rs. 7,43,40,000/- during the last 3 years ending March 31, 2023 / March 31, 2024.

4. The contractor should have GST registration.

* Similar work(s) means External painting work / Civil works for building(s) which must include component of external painting work.

The contractor will enclose necessary certificates / documents in support of the requirements mentioned at 1. to 4. above.

For the purpose, "Cost of work" shall mean gross value of completed work.

considered for shortlisting. **However, the contractor is also advised not to upload un-necessary / irrelevant documents, making it cumbersome for scrutiny. Only documents which have been asked should be submitted to expedite the process.**

4. The Institute reserves the right to inspect the completed similar works and/ or enquire with the various clients to verify the genuineness and to ensure the conformity with the details given. Further, the Institute reserves the right to reject any application, if the quality of the completed work(s) is not found to be satisfactory. The Institute also reserves the right to reject any application, if any of the information gathered is not in line with respect to the submissions made by the applicant.
5. Intending applicants are required to submit their details about their organization, experience and adequate evidence of their financial standing, etc., which will be kept confidential. Incomplete applications or applications without proper proofs for establishing their credentials may not be considered for shortlisting.
