About NISM

The National Institute of Securities Markets (NISM) is a public trust established in 2006 by the Securities and Exchange Board of India (SEBI), the regulator of the securities markets in India. The institute carries out a wide range of capacity building activities at various levels aimed at enhancing the quality standards in securities markets.

NISM sprawling 72-acre campus with a serene environment and state-of-the-art infrastructure at Patalganga (near Mumbai-Pune Expressway) was inaugurated by Shri Narendra Modi, incumbent Prime Minister of India, on December 24, 2016. This scenic campus offers full-time residential academic programmes for postgraduate students, short-term training programmes and faculty development programmes for market participants.

NISM has embarked on a fast-track expansion of its activities, both domestically and internationally, which will position the institute as a leading global player in knowledge dissemination and skills enhancement in the financial market's domain. The campus boasts of state-of-the-art design, finance library, IT infrastructure, well-equipped classrooms, seminar hall, conference hall, etc. It also has an amphitheatre, ultra-modern auditorium and multipurpose hall, recreation facilities for various activities. The entire campus is Wi-Fi enabled. NISM has been carrying out a wide range of capacity building activities aimed at enhancing quality standards in the securities markets and for increasing participation therein, addressing various stakeholders of securities markets, keeping in view its purpose, as mentioned below:

Industry Visits

Number of Visits: Each student will have one opportunity to visit institutions such as SEBI, Stock Exchanges and Depositories.

Visit Allocation: Due to capacity constraints, not all the students may visit the same institutions, but equivalent opportunities will be ensured

Program Duration

The program is structured over a **7-week** period, featuring contact classes held 5 days a week, with 3 sessions per day totaling 4.5 hours. The remaining time is dedicated to project work, self-study, assignments, and preparation for certification exams, ensuring a comprehensive and balanced learning experience.

Program Fee*

Rs. 50,000/- (Rupees Fifty Thousand only) per student, inclusive of GST

* The fees include twin-sharing hostel accommodation, food in the students' mess, local transport for MII visits, academic delivery, and two NISM Certification Examination for one attempt. Personal expenses of students, like use of laundry facilities, cafeteria, medical expenses, etc., are not included in the above fees. Students will have access to all the standard facilities on the campus like sports, recreation, library, etc.

- Payment Schedule: Full payment is due at least 15 days before the program start date.
- Fee Adjustments: Subject to change if the government revises GST rules.
